2. I declare I have had an opportunity to consult with my professional advisers in relation to my investment in the Quest II Fund and I am fully aware of the risks entailed in investing in the Quest II Fund.
3. I am exempt from Capital Gains Tax by virtue of being an Approved Retirement Fund / Approved Minimum Retirement Fund / Exempt Pension Scheme / Personal Retirement Savings Account / Personal Retirement Bond
4. I agree to notify the trustee immediately if I become aware that of the representation is no longer accurate and complete in all respects. I agree to indemnify the trustee against any loss or any nature whatsoever arising as a result of any breach or any of the representations, warranties or declarations given by me in this application form.
5. I agree that all representations, warranties and declarations which I make or give here will apply with respect to future acquisitions of Units in the Quest II Fund as if repeated in full at the time of the future acquisition.
6. I accept and agree that the trustee reserves the right at its sole discretion to accept or reject in whole or in part this application.

I acknowledge the right of the trustee of the Quest II Fund to issue such number of Units to me upon the transfer of initial or subsequent subscription monies into the account of the Series Trust as the trustee may in its sole discretion determine in accordance with the provision of the Declaration of Trust. I further acknowledge and agree that the transfer of monies by me into the account of the Series Trust will be deemed to be an irrevocable subscription for Units in Quest II Fund.

10. I understand that during the Term of the Series Trust, the redemption of my Units shall be subject to restrictions which may adversely affect my ability to redeem my Units.
